General

The Gastonia Housing Authority owns and operates 400 units of public housing at three different locations:

Cameron Courts/Weldon Heights (family and one-bedroom apartments for elderly)

Mountain View (family and one-bedroom apartments for elderly)

Linwood Terrace (elderly only)

Applying for Public Housing

Applications for public housing are **NOT** taken at the GHA Central Office at 340 W. Long Avenue.

Families wishing to apply for public housing must apply at the location(s) where they wish to live. For example, if a family prefers to live only at the Mountain View property, they would go to the management office at 425 Edwin Street and make application with the site manager. If the family did not have a preference they would go to both the Mountain View and Cameron/Weldon (1305 N. Weldon Street) and make application at each management office.

An applicant will only have to fill out an application at the first property visited. If the applicant intends to apply at another property, as a courtesy the site manager will fax a copy of the application to the other properties.

The application will be held at the other properties until the applicant visits the property. At that time, the application will be entered on the waiting list for that property.

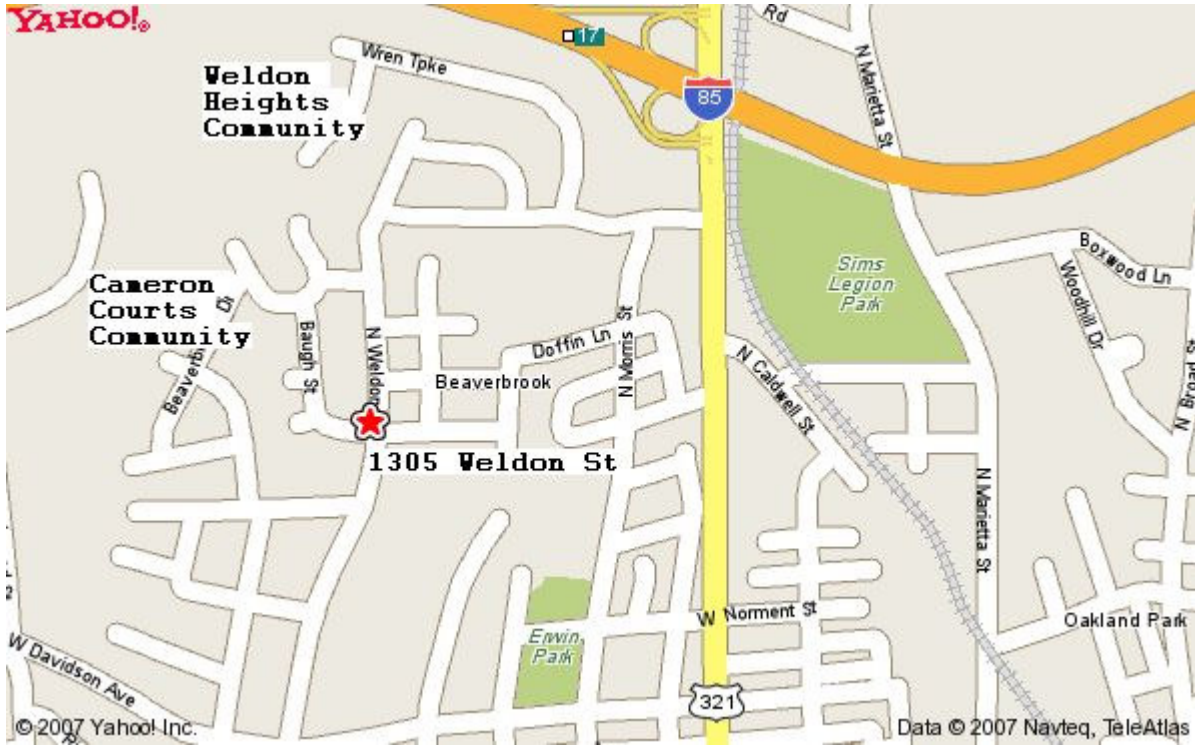

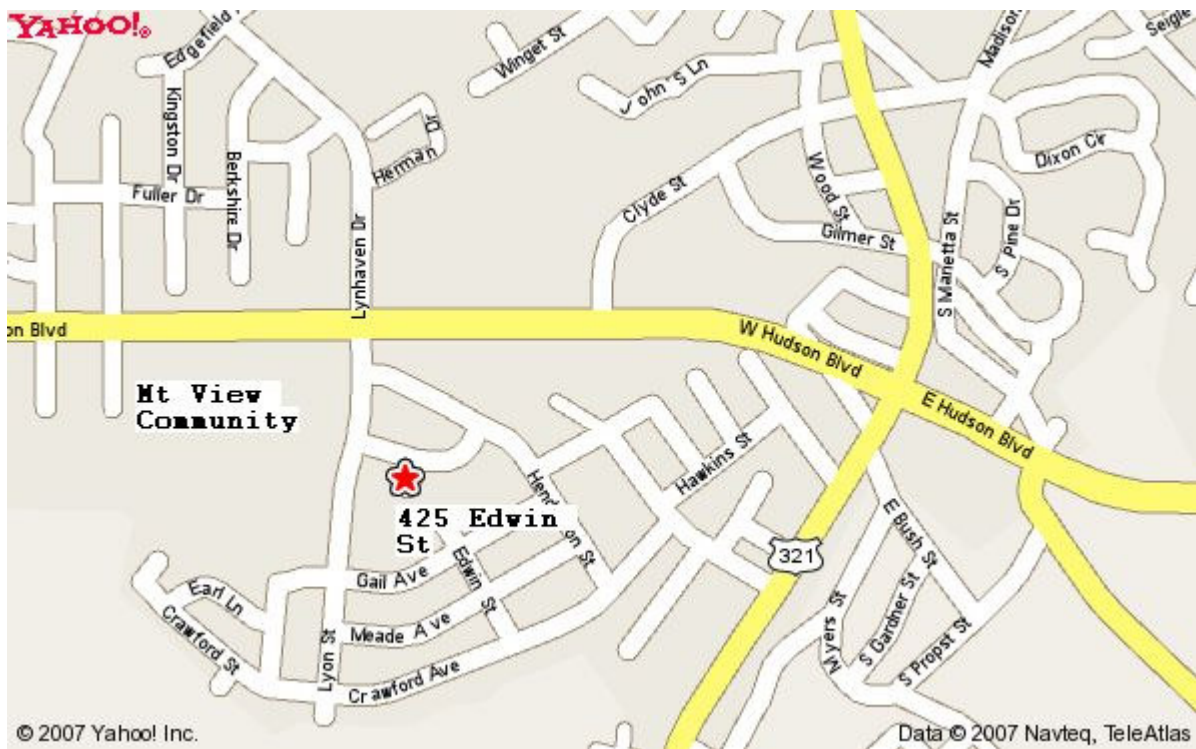

Turn left onto RADIO ST. go 0.4 miles
Turn LEFT onto N WELDON ST. go 0.2 miles
End at **1305 N Weldon St**

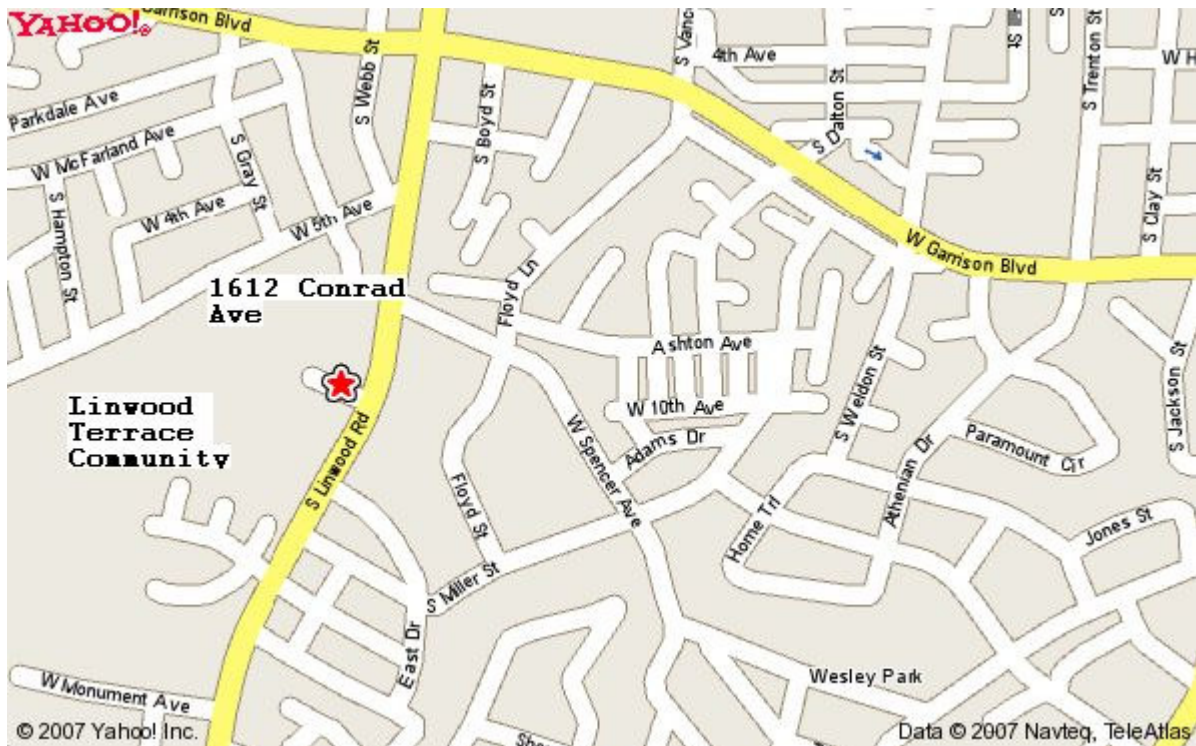

Go west on W LONG AVE / NC-7 toward YORK ST / US-321 N, go <0.1 miles
Turn left onto N CHESTER ST / US-321 S / Continue to follow US-321 S, go 2.2 miles
Turn right onto W HUDSON BLVD. go 0.6 miles
Turn left onto LYON ST. go 0.1 miles
Turn left onto SOUTHSIDE AVE. go <0.1 miles
Turn right onto EDWIN ST. go <0.1 miles
End at **425 Edwin St**

Go west on W LONG AVE / NC-7 toward YORK ST / US-321 N, go < 0.1 miles
Turn left onto N CHESTER ST / US-321 S, 0.8 miles
Turn right onto W GARRISON BLVD, go 1 mile
Turn left onto S LINWOOD RD. go 0.4 miles
Turn right onto CONRAD AVE. go <0.1 miles
End at **1612 Conrad Ave**
